This is the last chance for 2023 admission candidates, as per the programme regulations

Regular (2025 admission only) candidates should make the payment through SBI e-pay (payment gateway). Printouts of applications of these candidates need not to be sent to the University. This shall be retained in the College and shall be made available for verification if the University demands. Supplementary/Improvement candidates shall also make payment through 'SBI e-pay (payment gateway). They shall submit the printouts of application along with the Fee receipts in the University on or before the last date prescribed.

The eligible candidates who receive the grant directly to their bank account shall **either remit the examination fee online during registration without opting fee concession or remit the amount to the University as and when it is received from the Government Department concerned.** These candidates shall **submit the affidavit in annexure-I, if the examination fee is not remitted during registration.**

The candidates who receive the grant through the institution's bank account may opt for fee concession during registration. The Head of the Institution shall credit the examination fees of these candidates to the Kannur University Fund and inform details of such remittance to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the Principal of the College shall reimburse the amount to the candidate.

The Principals shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same, along with the affidavits submitted by the candidates receiving grant directly to their bank account, who have not remitted the examination fee during registration before the last date prescribed.

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Applications, as per University rules. The deadline for submitting applications and data as per the above schedule will not be extended.



Candidates with shortage of attendance will not be issued hall tickets unless the Principal recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.
