ORDER

1. Vide paper read (1) above, University Order was issued, granting the last chance for Re-Registration (applicable to all semesters) of B.Tech. students, who have taken admission from 2007 to 2014, with a proposal to invite application in September 2020 and to conduct examination in October 2020. Further intimated the Examination Branch, to issue a press release in this regard.

2. Examination Branch, while considering the above mentioned order, placed before the Syndicate, the matter whether 2013 & 2014 Batch students need Re- registration and whether Re-Registration chance is to be extended to the Part time B.Tech. Students (2011 & earlier), for further clarification.

3. As per paper read (2) above, the meeting of the Syndicate held on 15.07.2020, resolved vide resolution No. 2020.324 to conduct Mercy Chance Examination for the failed candidates of the B.Tech.course, 2012 and earlier admissions(2011 &earlier for Part Time), after levying re-registration fee of Rs.5000/-and Rs.500/-per paper and to conduct Supplementary Examinations for eligible candidates of 2013 admission (2012 onwards, for Part Time).

4. The Examination Branch vide paper read (3) above requested to incorporate necessary changes proposed by the Syndicate and to revise the University Order read vide paper (1) above, issued earlier in this connection.

5. The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11 (1) Chapter III of Kannur University Act 1996 and all other enabling provisions read together with, issued the following orders.

a) One last chance is granted for Re-Registration (applicable to all semesters) for candidates of B.Tech. 2012 and earlier admission (Regular), 2011 & earlier admission (for Part Time), after levying a Re-Registration fee of Rs.5000/- (Rupees Five Thousand only) and Rs. 500/- (Rupees Five Hundred only) per paper and Mercy Chance examination shall be conducted.

b) Supplementary Examination shall be conducted for the eligible candidates of 2013 admission onwards (Regular) and 2012 admission onwards, for the Part Time candidates.

6. The U. O read vide paper (1) above stands modified to this extent.
