This is the last chance for 2017 admission candidates, as per the programme regulations.

Mode of fee payment will be SBI e-pay for regular candidates (2022 Admn) and SBI Collect for Supplementary/ Improvement candidates.

The printouts of online applications of 2022 Admission regular candidates shall be retained in the College itself. Supplementary/Improvement Candidates shall submit the printouts of Applications and Chalan receipts to the University on or before 07.06.2023

The Principals/ Assistant Directors shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same, along with the affidavits submitted by the candidates receiving grant directly to their bank account, who have not remitted the examination fee during registration

The eligible regular candidates who receive the grant directly to their bank account may either remit the examination fee online (SBI e pay) during registration without opting fee concession or remit the amount to the University as and when it is received from the Government Department concerned. These candidates shall submit the affidavit in annexure I if the examination fee is not remitted during registration

The regular candidates who receive the grant through the institution's bank account shall opt for fee concession during registration. The Head of the Institution shall credit the examination fees of these candidates to the Kannur University Fund and inform details of such remittance to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the Head of the Department shall reimburse the amount to the candidate

The deadline for submitting applications and data as per the above schedule will not be extended

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/printout of applications, as per the university rules.

Candidates with shortage of attendance will not be issued hall tickets, unless the Principal recommends and states that shortage is within the condonable limit and the applications for condonation have been forwarded to the Registrar.
