Fee shall be remitted only through **SBI e-pay**.

The printouts of online applications, in the case of Regular students shall be retained in the Department itself.

The Course Co-ordinator shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same to the undersigned.

Candidates availing fee concession, who receive the grant directly to their bank account shall either remit the fee while registration, or remit it as and when it is received from the Government Department.

Fee in respect of candidates, availing fee concession received through the institution's bank account, shall be credited to the Kannur University Fund by the Course Co-ordinator and the undersigned shall be informed of the details of such remittance, without delay.

All SC/ ST candidates claiming fee concession (receiving the grant directly to their Bank accounts) shall submit the affidavit (Annexure I) attached to the notification, to the Course Co-ordinator and Course Co-

ordinator shall verify , certify and forward the affidavits to the University in time.

Course Co- ordinator shall submit the duly filled and signed certificate (Annexure II) attached to the notification pertaining to all other eligible candidates availing fee concession (receiving the grant through the institution's bank account), who have not remitted the examination fee during registration .

If any candidate, receiving grant through the institution's bank account has remitted the examination fee during registration, the Course Co- ordinator shall take necessary action to reimburse the amount to the candidates.

Results of the candidates with fee due, Non production of Qualifying certificates and Non production of condonation order for attendance shortage will not be released .

Consolidated Grade Cards , Provisional Certificates will not be issued to candidates whose personal data needs to be corrected .

Penalty shall be levied for delayed submission/incorrect submission/ non-submission of data/Application, as per the University rules.

Candidates with shortage of attendance shall not be issued hall tickets, unless the Head of the Department / Course Director recommends and states that the shortage is within the condonable limit and the applications for condonation have been forwarded to the Registrar.
