Fee shall **only be remitted through SBI e-pay**.

The printouts of the online applications, in the case of Regular students shall be retained in the Concerned Department itself.

The Heads of the Departments/ Course Directors shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same to the undersigned. Candidates availing fee concession , who receive the grant directly to their bank account shall either remit the fee while registration **(through SBI e-pay), or remit it as and when it is received from the Government Department** . Fee in respect of candidates, availing fee concession received through the institution's bank account, shall be

credited to the Kannur University Fund and the undersigned shall be informed of the details of such remittance, without delay. The Heads of the Departments/ Course Directors shall verify, certify and forward the affidavits (attached with the applications / notification) submitted by the SC/ST candidates (receiving the grant directly to their Bank accounts) and other eligible candidates availing fee concession (receiving the grant through the institution's bank account), who have not remitted the examination fee during registration.

If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the Head of department shall take necessary action to reimburse the amount to the candidate.

Penalty shall be levied for delayed submission/incorrect submission/ non-submission of data/Application, as per the University rules.

Candidates with shortage of attendance shall not be issued hall tickets, unless the Head of the Department / Course Director recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.
