**This is the final chance for 2014 admission candidates to take the Eighth semester examination of B.A.LLB. Programme.**

**Mode of payment of fees will be SBI e-pay for 2019 & 2020 admission candidates and SBI Collect for 2014 to 2018 admission candidates .**

The Printouts of online application (Supple-2019 admission) need not be sent to the University. However Printouts of online application of Regular candidates (2020 admission) should be retained in the department itself.

**2014 to 2018 admission candidates shall submit the applications in the form downloaded from the university website, on or before the last date , to the Controller of Examinations.**

The Head of the Department shall log in and download the detailed statement of fees remitted by the regular candidates and forward an attested copy of the same, along with the affidavits submitted by the candidates receiving grant directly to their bank account, who have not remitted the examination fee during registration.

The eligible regular candidates who receive the grant directly to their bank account shall **either remit the examination fee online (SBI e pay) during registration without opting fee concession or remit the amount to the University as and when it is received from the Government Department concerned.** These candidates shall **submit the affidavit in annexure I if the examination fee is not remitted during registration.**

The regular candidates who receive the grant through the institution's bank account may opt for fee concession during registration. The Head of the Institution shall credit the examination fees of these candidates to the Kannur University Fund and inform details of such remittance to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during

registration, the Head of the Department shall reimburse the amount to the candidate

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Application, as per the university rules. The deadline for submitting applications and data as per the above schedule will not be extended.

Students of 2014 and 2015 admissions should re-register themselves for the programme by remitting re-registration fee of ₹ 4000/- as per reference cited (1) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form for examination. The results of these students will be published only after the completion of re-registration process.

**Candidates with shortage of attendance will not be issued hall tickets, unless the Head of the Department recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.**
