**ORDER**

1. As per the paper read (1) above, the Regulation, Scheme, Syllabus, Model Question Paper & Pattern of Question Papers for BA LLB Five Year Course was implemented in the University Teaching Department with effect from 2016 admission.

2. As per the Clause 9.4 of the above mentioned Regulation, "There shall be no chance to improve either the internal assessment marks or the external examination marks".

3. Meanwhile, BA LLB students, to whom the 2016 Regulation is applicable and who could not complete the programme submitted Petition vide paper read (2) above, before the Vice Chancellor requesting that they also be given a chance for Internal Improvement as given to the students of 2009 Regulations, to complete the programme.

4. Considering the representation, the Vice Chancellor vide paper read 3 above, ordered to place the matter before the Academic Council, after obtaining the Remarks of the Head, School of Legal Studies.

5. In reply, the Head, School of Legal Studies intimated vide paper read (4) that the Department will proceed with the decision taken by the University in this regard.

6. Subsequently, the XXVIII<sup>th</sup> Meeting of the Academic Council, vide paper read (5) above considered the request of BA LLB students to grant permission for Internal Improvement and resolved to extend the provision for the Internal Improvement, to the 2016 Regulation candidates also.

7. the Minutes of the Meeting of the Academic Council was approved and published.

8. The one Mercy Chance for Internal Improvement for BA LLB students of 2009 Regulation was granted, subject to the Guidelines prepared by the three member Committee constituted for this purpose, comprising with the Head, Department of Law of the University, Chairman, Board of Studies (Law) and Dean, Faculty of Law vide paper read 6 above.

9. Considering the matter, the Registrar vide paper read (7), ordered that the Guidelines for internal improvement, fixed for the BA LLB candidates of 2009 Regulation be made applicable for the Internal improvement of the 2016 Regulation candidates also and entrusted the Controller of Examinations for fixing the Fee for internal improvement.

10. Therefore, as resolved by the Meeting of the Academic Council, the clause 9.4 of the Regulations of the BA LLB programme w e f 2016 admission is relaxed and the following orders are therefore issued.

**11. The Students under 2016 Regulation of the BA LLB course may avail ONE Mercy Chance per Subject/Paper (excluding Clinical/Practical papers) for improving the Internal Assessment marks, subject to the following conditions.**

(i) Re-doing of Internals for the Improvement of marks shall be permitted only after completion of the course. During the course period, no re-doing of Internals shall be allowed in any subject in the curriculum.

(ii) The following categories of students shall not be eligible for Improvement of Internal assessment marks obtained in a subject /paper.

a. Students who have successfully completed the Course.

b. Students who have secured 50 percent or more Marks for Internal assessment in the subject/paper concerned.

c. Students who have passed the subject/paper concerned.

(iii) An application for Improvement of Internal assessment marks obtained in a subject/paper by re-doing the same shall be made within one year from the date of written examination in the last subject in the final Semester of the course concerned, conducted by the University. Provided that this condition may be waived once, after Notification of these Guidelines, for students in whose case the one year period has already elapsed.

(iv) Only one chance shall be allowed for re-doing internals for Improvement of internal marks for a student in a particular subject/paper. If the candidate is eligible for re-doing internals for more than one paper/subject and desires to do so, a single application should be made for the purpose for all the papers.

(v) Each student who fulfils the above conditions and intends to re-do the internals should make an Application to the University and remit the prescribed fee per paper, as fixed by the University. The fee at the prescribed rate for all the papers/subjects for which the candidate desires to re-do internals shall be paid at a single instance.

(vi) On verification of the eligibility of the student for re-doing internals, the University may issue an Order to the Departments/College/ Institution concerned for the purpose.

(vii) The Head of the Department/College/Institution, on receipt of the University Order, shall make arrangements for re-doing the Internals, subject to the condition that the Teacher who valued the original Internal assessment shall not be entrusted with the Re-evaluation of the Internals.

(viii) The student shall re-do the required components of internal assessment as instructed by the

teacher concerned in accordance with Regulations applicable to the candidate concerned. The component of marks for attendance, if any, shall be the marks obtained by the candidate while she attended the semester on a regular basis.

(ix) A maximum of 90 working days may be given for completing the Internal assessment process by the teacher concerned.

(x) The revised marks shall be forwarded from the Department/College/Institution to the University within 100 working days from receipt of the University order.

(xi) Improved Internal marks is to be given in the Session in which candidate has scored the highest external mark in the subject. (The candidate should submit copy of the Mark list along with the application for Internal marks improvement).

(xii) The Month and Year of passing of the subject as a result of the Internal improvement shall be considered as the Month and Year of passing the subject and reflected in the Mark Sheet accordingly.

12) The U O read vide paper (1) above, stands modified to this extent.

Orders are issued accordingly.
