This is the final chance for 2015 admission candidates to take the Tenth semester examination of **B.A.LLB. Programme**.

Mode of payment of fees will be SBI e-pay for 2019 & 2020 admission candidates and SBI Collect for 2015 to 2018 admissions candidates.

The printouts of online applications of 2019 admission supplementary candidates need not be sent to the University. The printouts of online applications of regular candidates (2020 admission) shall be retained in the department itself. 2015 to 2018 admission candidates shall submit the applications in the form downloaded from the university website, on or before the last date , to the Controller of Examinations.

The Head of the Department of Law shall forward the statement of fees on or before the last date prescribed, to the Controller of Examinations. The HoD shall verify and certify the affidavits submitted by the SC/ST candidates (receiving the grant directly to their bank accounts) and other eligible candidates availing fee concession (receiving the grant through the institution's bank account) who have not remitted the examination fee during registration. . The candidates who receive the grant directly to their bank account shall remit the fee amount in the University as and when it is received from the Government Department concerned. Fee in respect of candidates availing fee concession received through the institution's bank account shall be credited to the Kannur University Fund and details of such remittance shall be informed to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the department shall reimburse the amount to the candidate.

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Application, as

per the university rules. The deadline for submitting applications and data as per the above schedule will not be extended.. Fee in respect of candidates availing fee concession shall be collected from the Government Departments concerned and the amount shall be credited to Kannur University Fund and such remittance shall be informed to the Examination Branch.

Candidates with shortage of attendance will not be issued hall tickets until the Head of the Departments recommends and states that the shortage is within condonable limit and the application for condonation has been forwarded to the Registrar.

2015 & 2016 admission Students should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference cited (ii) above. Those candidates who have already re-registered should attach the re-registration memo along with the application form for examination. The results of these students be published only after the completion of re-registration process.

The application for re-registration (in the format available on the university website) along with the chalan receipt should be submitted to the Registrar whereas, the application forms for examinations along with the chalan receipt should be submitted to the Controller of Examinations.
