As the Registration in ABC portal is mandatory, utmost care must be taken to enter the correct ABC ID of every candidate in the Application for registering the Examination.

The candidates shall remit the fee via online.

The printouts of online Applications of candidates shall be retained in the Department concerned itself.

The Head of the Department/ Course Director shall log in and download the detailed statement of fees remitted by the candidates and forward an attested copy of the same to the undersigned.

Candidates availing fee concession, who receive the grant directly to their bank account shall either remit the fee while registration, or remit it as and when the amount is received from the Government Department.

Fee in respect of candidates, availing fee concession (OEC) received through the institution's bank account, shall be credited to the Kannur University Fund by the Heads of Department and the undersigned shall be informed of the details of such remittance, without delay.

All SC/ ST candidates claiming fee concession (receiving the grant directly to their Bank accounts) shall submit the Affidavit (Annexure I) attached to the Notification, to the Head of Department/Course Director and Head of the Department/Course Director shall verify, certify and forward the Affidavits to the University in time.

The Head of the Department/Course Director shall submit the duly filled and signed certificate (Annexure II) attached to the Notification pertaining to all other eligible candidates availing fee concession (receiving the grant through the institution's bank account), who have not remitted the Examination fee during Registration.

If any candidate, receiving Grant through the institution's bank account has remitted the Examination fee during Registration, the Head of Department /Course Director shall take necessary action to reimburse the amount to the candidates.

Results of the candidates with fee due, Non production of Qualifying certificates and Non production of Condonation order for attendance shortage will not be released.

Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Application, as per the University rules.

Candidates with shortage of attendance will not be issued Hall tickets, unless the Head of the Department / Course Director recommends and states that the shortage is within the condonable limit and the Application for condonation have been forwarded to the Registrar.
